Towards the G7 Hiroshima Summit and G7 Health Ministers' Meeting in Nagasaki ~Joint statement issued with the International Council of Nurses to G7 Leaders and Health Ministers~

On May 11, the Japanese Nursing Association (JNA), together with the International Council of Nurses (ICN), issued a joint statement to the G7 Hiroshima Summit and G7 Health Ministers' Meeting in Nagasaki.

The JNA has already submitted its recommendations on February 21, however, we decided to issue a joint statement with the ICN in order to further strengthen its message to the world. The joint statement resonates with the content of the JNA's recommendations and further refers to the role of nurses in terms of supporting peace. The G7 summit will be held in Hiroshima Prefecture from May 19-21, preceded by a meeting of health ministers in Nagasaki Prefecture on May 13-14. The G7 members have identified the promotion of universal health coverage (UHC) as one of their key priorities.

Considering the experience of the COVID-19 pandemic and the global trend of rapidly declining birthrates and ageing populations, the ICN and the JNA propose three recommendations to support the nursing professionals and promote the active role of nurses in strengthening health systems and achieving UHC.

《Recommendations》

1. Secure and rebuild the workforce for healthcare services to realize and strengthen UHC
2. Establish more effective and efficient healthcare system
3. Increase investment in healthcare to develop better systems that are more resilient and equitable

Participation in G7 side events

The JNA plans to participate in the exhibition, which will be held as a side event of the G7 Health Ministers' Meeting. We will set up a booth and introduce the UHC and nursing experience in Japan, challenges related to healthcare, and prospects for nursing and the JNA's initiatives through panel displays.

Publication of “Nursing in Japan”

Prior to the side event of G7 Health Ministers' meeting, in this April the JNA published a revised edition of “Nursing in Japan”. It has been published by the JNA since 2005. “Nursing in Japan” introduces the institutional framework in Japan for nursing professional qualifications, the nursing delivery system, and more. The edition is the first revision following the COVID-19 pandemic after the 2016 edition. We hope that it will be useful in discussions towards the realization and sustainment of UHC worldwide.

Joint Statement to the G7 Leaders and Health Ministers
by the International Council of Nurses
and the Japanese Nursing Association

On the occasion of the G7 Hiroshima Summit and G7 Health Ministers' Meeting in Nagasaki in May 2023, the International Council of Nurses (ICN) and the Japanese Nursing Association (JNA) call on the G7 to commit to action to support nurses and healthcare workers worldwide.

The G7 members have been committed to the promotion of Universal Health Coverage (UHC) as one of their key issues. Reflecting on the experience with the COVID-19 pandemic and the global trend of rapidly declining birth rates and ageing populations, ICN and JNA propose three recommendations in order to support nurses and promote their active role in strengthening systems and realizing UHC.

1. Secure and rebuild the workforce for healthcare services to realize and strengthen UHC
2. Establish more effective and efficient healthcare systems
3. Increase investment in healthcare to develop better systems that are more resilient and equitable

As the largest health profession in the health workforce, nurses are intrinsically linked to the ability of countries to achieve UHC and the Sustainable Development Goals. They work across the life course and in all settings and work beyond health to uphold human rights, fight to reduce inequalities and empower people and communities. UHC will not be achieved without bold and innovative approaches to educate, develop and retain the health workforce.

As such, ICN and JNA encourage governments to heavily invest in a competent health workforce with a focus on nurses and midwives. This includes quality education, recruitment and retention strategies and assurance of decent work and fair pay. ICN and JNA firmly believe that health is the foundation for prosperous people, communities and economies. Achieving UHC requires political leadership beyond that of the health sector and we urge states and governments to drive political leadership for UHC in all sectors. We believe that investment in nursing is needed now if we are to meet the healthcare challenges of the future.
